In view of the following definitions:

An Expert of the FINPEDMED Expert Board is a member of FINPEDMED acting as an independent contractor (consultant) representing his/her specialty / sub-specialty within the field of Pediatrics; providing independent views; taking part in discussions as a group member; and promoting joint proposals for Expert Board decision-making when performing FINPEDMED Services, i.e. assignments for Expert Boards. The FINPEDMED Services are administrated by FINPEDMED's legal entity CRI HUCH Ltd., whereas CRI HUCH Ltd. is a service provider enabling consultant contact between FINPEDMED and the service Requesters, i.e. sponsors. "Confidential Information" means all information, facts, data, and any other matters of which I acquire knowledge, either directly or indirectly, as a result of my FINPEDMED Activities.

"Confidential Documents" mean all drafts, preparatory information, documents, and any other material, together with any information contained therein, to which I have access, either directly or indirectly, as a result of my participation in FINPEDMED Activities. Furthermore, any records or notes made by me relating to Confidential Information or Confidential Documents shall be treated as Confidential Documents.

I understand that I may be invited to participate in certain FINPEDMED activities and hereby undertake:

- To do all Expert Board assessments as an independent consultant, impartially and transparently but without official validity, due to given statements are not official decisions and they are not binding in any respect.
- To treat all Confidential Information and Confidential Documents under the conditions of strict confidentiality.
- Not to disclose (or authorize any other person to disclose) in any way to any third party any Confidential Information or Confidential Document.
- Not to use (or authorize any other person to use) any Confidential Information or Confidential Document other than for the purposes of my work in connection with FINPEDMED activities.
- To dispose of Confidential Documents as confidential material as soon as I have no further use for them.

This undertaking shall not be limited in time, but shall not apply to any document or information that I can reasonably prove was known to me before the date of this undertaking or which becomes public knowledge other than as a result of a breach of any of the above undertakings.
