Requires familiarization and retrieval of information on the subject.</p> <p>Duration: 1 hour – max 2 hours (expert work).</p>	<p>Service fee incurring Sponsors (paid to CRI HUCH):</p> <p>350€ (one-time payment)* + VAT or similar taxes.</p> <p><u>*After 1-2 hours, the fee will be determined according to the following fees described below.</u></p>
<p>Fee-based hourly services (consultations)</p> <p>This includes expert work in various kinds of assignments in the field of drug development, evaluating and reviewing PIP's, or other similar documentation. This may include more detailed feasibility assessments, written statements, and consultations, in the form of subsequent Expert Reports or other similar documents. Requires in-depth familiarization and retrieval of information on the subject beforehand. The place for performing the tasks is located in Finland.</p> <p>Duration: from 2 to max. 8 hours (expert work).</p>	<p>Service Fee incurring Sponsors (paid to CRI HUCH):</p> <p>350€ / 1st hour*, and 250€ for each following hour / one single extensive feasibility assessment, or one Expert Report, or equivalent + VAT or similar taxes.</p>
<p>Participation in teleconferences</p> <p>This includes participation in teleconferences, which may involve negotiations, as an active participant based in Finland. Requires in-depth familiarization and retrieval of information on the subject beforehand.</p> <p>Maximum duration: Half day (expert work).</p>	<p>Service Fee incurring Sponsors (paid to CRI HUCH):</p> <p>750€ (one-time payment) + VAT or similar taxes.</p> <p>In case no toll-free number is provided for the teleconference, the Sponsor shall pay the respective telephone costs.</p>

<p>Participation in whole day meetings or conferences</p> <p>This includes participation in whole day meetings or conferences in Finland or abroad. Requires in-depth familiarization and retrieval of information on the subject beforehand.</p> <p>Maximum duration: One day (expert work).</p>	<p>Service Fee incurring Sponsors (paid to CRI HUCH):</p> <p>1500€ (one-time payment) + VAT or similar taxes.</p> <p>Travel costs, per diem allowances as confirmed by the Finnish Government, and other out-of-pocket expenses (e.g. registration fees) are to be reimbursed by the Sponsor.</p>
<p>Project-based or long-term assignments</p> <p>This includes expert work in long-term assignments in the area of drug development, as well as evaluating PIP's or other corresponding documentation. Includes written statements, or other similar documentation resulting from the work. Requires in-depth familiarization beforehand as well as continuous commitment. The place for carrying out the tasks is located in Finland.</p> <p>Maximum duration: 3 months (expert work as additional work out of normal office hours.)</p>	<p>Service Fee incurring Sponsors (paid to CRI HUCH):</p> <p>350€ / hour, or 1500€ / day + VAT or similar taxes.</p> <p>The fee will be determined by the nature of the assignment; e.g. an hourly fee or a daily fee. Travel costs, per diem allowances as confirmed by the Finnish Government, and other out-of-pocket expenses (e.g. registration fees) are to be reimbursed by the Sponsor.</p>
